PROJECT DESCRIPTION: Shoreline Substantial Development Permit (SSDP) to allow the construction of a new 463.5 square feet fixed pile dock and boat lift with canopy. The subject property is located in the R-4 zoning district and Lake Sammamish Shoreline Residential/Urban Conservancy Environment Designations. The existing dock will be removed before the new dock is built.

The final decision of the City, as issued by the City of Sammamish Hearing Examiner, is appealable to the Washington State Shoreline Hearings Board in accordance with RCW 90.58.180 and SMC 25.08.090.
