Dear Ms. Auld:

On February 27, 2018, the Department of Ecology (Ecology) received the City of Sammamish decision approving in part, subject to conditions, your SDP for reconstructing an approximately 426-foot-long segment of the East Lake Sammamish Regional Trail and establishing a 30-stall paved parking lot known as the Inglewood Hill Parking Lot, as an accessory to the trail. The project would include installation of a restroom facility, an information kiosk, an access ramp to connect the parking area and restroom to trail, and infrastructure improvements and adjustments associated with the project. The current interim trail condition would be widened to 12 feet of paved surface with two-foot gravel shoulders and a one-foot clear zone on both sides. The City of Sammamish conditions would exclude the proposed kiosk, picnic shelter, and restroom. This work will occur in the Shoreline Residential environment designation of Lake Sammamish, a shoreline of state significance.

By law, local governments must review all SDPs for compliance with:

- The Shoreline Management Act (Chapter 90.58 RCW).
- Ecology's SDP approval criteria (Chapter 173-27-150 WAC).
- The City of Sammamish Local Shoreline Master Program.

Local governments, after reviewing SDPs for compliance, are required to submit them to Ecology. We have received your approved in part, subject to conditions, SDP.

What Happens Next?

Before you begin activities authorized by this permit, the law requires you wait at least 21 days from February 27, 2018, the "date of filing." This waiting period allows anyone (including you) who disagrees with any aspect of this permit, to appeal the decision to the state Shorelines

Hearings Board. You must wait for the conclusion of an appeal before you can begin the activities authorized by this permit.

The Shorelines Hearings Board will notify you by letter if they receive an appeal. We recommend you contact the Shorelines Hearings Board before you begin permit activities to ensure no appeal has been received. You may reach them at (360) 664-9160 or <http://www.eho.wa.gov/>.

Other federal, state, and local permits may be required in addition to this shoreline permit.
